5. **We are required by law to report identification attached to all decisions. For any IPDPs, Activity Proposals or Verifications which are denied, state ID numbers will be provided.**
6. **You must have an approved IPDP on file in order to have any professional development approved by the LPDC.**
7. **The LAW has been CHANGED: It is no longer required for educators to have a Masters degree or equivalent by the SECOND RENEWAL of their 5-year Professional Educator License.**
