PRESENTATION

The 7th Grade choir led by Ms. Reiko Carey performed three songs in preparation for their winter concert.

Mr. LeMon Bradford, Learning Center Principal

This year we had our first big transition in staff. Mr. Townsend along with Mr. Freilino took administrative positions in the district. We then added Mr. Petsche along with former student Mr. Dawson to the staff. We also added an intervention specialist Mrs. Sauer to work with the academy students. Out of the 80 possible seats in the day program 78 of them are filled with students. In the high school section grades 10-12 of the program the currently full with 40 students. The academy section of the program with 8th grade has 18 students and 9th grade is full with 20 students. We have a total of 11 students potential to graduates from the day program with another 12 potential graduates from that VLA afternoon program. the Learning Center graduated 23 students last school year.

Mr. Chris Sauer, Middle School Principal

The middle school invited the 7th grade choir to perform for the school board. They sang a few numbers, some of which served as a preview for their upcoming concert. The middle school has been designated a "Focus School" this year by the Ohio Department of Education. This means we are a school that receives Title 1 funding and has gaps in student achievement. We have maintained the same structure and schedule as in past years. We have 8 interdisciplinary teams of teachers. One new academic change is the co-teaching model. One team on each grade level in Language Arts and Math has two teachers. This will better serve our growing population of students with special needs. We have also added a middle school "Drama" course for 7th and 8th grade students. Our athletics programs have benefited from the improvements made in the gymnasium. These improvements include new bleachers, fresh paint, a new curtain, and graphics on the walls.

The middle school is doing more student recognition than ever. Students are being recognized daily for academics and positive behavior. We recently hosted our first quarterly family engagement night, where we recognized the top 10 from each grade level and discussed school safety. There are more good things to come from GHMS.

RECOGNITIONS/COMMENDATIONS

SUPERINTENDENT'S REPORT

Thank you Mr. President. Students at all levels of the Garfield Heights City Schools have been hard at work at various curriculum and co-curricular activities that the district believes will help them to become not only better students, but more productive members of a global society in the future. These recent examples have taken place at the high school, middle school and at the elementary levels.

High School Mock Interviews: Just recently, Garfield Heights High School students enrolled in the Senior Seminar Class participated in Mock Interviews, with real-world experience from the corporate world. After having completed an update of their resumes and portfolios, students engaged in one-on-one interviews with business and non-profit leaders from the community. This interview experience is designed to help prepare our Bulldog students with the experience that will prepare them for future, live interviews. Thank you to those individuals from the community, who took time to interview our students and help them with their future endeavors.

Middle School Family Engagement Night: Last week, the Middle School continued with its efforts to engage parents and families by hosting its first family engagement night of the school year. Staff and administrators introduced themselves to the nearly 100 participants. Principal Chris Sauer made a special presentation of the Top Ten students by GPA per grade in front of the audience. Recent studies demonstrate that family engagement is a top reason for student success in his or her academic endeavors, and thank you to those who participated.

The Annual Food Drive: The Garfield Heights City Schools, once again, is participating in its Annual Non-Perishable and Canned Food Drive. Running from Monday, November 9 until this Friday, November 20, 2015, the organizers of this event which has been led by Amy Sumen over the years, are attempting to reach of goal of 300 canned foods donated. All items collected go to benefit the resource centers in Garfield Heights, including the City Food Bank, The Rock Church, and the Word of Righteousness. A special THANK YOU to everyone involved.

William Foster Girls on the Run Team: Visited Marymount Place residents on Wednesday, November 4th as part of their curriculum where they participated in a Community Impact Project. The girls introduced themselves to the residents and participated in a game of chair volleyball with the residents. The girls got the opportunity to share ice cream in the parlor and meet members of the Walk-a-Hall-ics group. All in all, the girls enjoyed their time together as a team and learned a lot about the importance of reaching out to the community.

Ohio State Representative Stephanie Howse met with Maple Leaf Students. She discussed the role that the House of Representatives plays in school reform, the qualifications being a representative and the importance of voting.

Kent State University Visit: Mrs. Regula, Mr. Sharp, Ms. Herberger and Mrs. Randall took 37 High School students to visit Kent State University. They wanted to give our students a taste of college life.

Students from the Middle School will evacuate by walking to the K-Mart corporate location, through the neighborhood immediately south of the Middle School. Maple Leaf students will evacuate by walking to the parking lot of the Nazarene Church, on the east side of Turney Road. Once completed, all students will be bussed back to their respective schools.
