Resolution No. 2015-024

**A RESOLUTION DECLARING IT NECESSARY TO SUBMIT THE
QUESTION OF LEVYING AN ADDITIONAL TAX IN EXCESS OF THE
TEN-MILL LIMITATION TO THE ELECTORS OF THE GARFIELD HEIGHTS CITY
SCHOOL DISTRICT PURSUANT TO SECTION 5705.21 OF THE REVISED CODE**

BE IT RESOLVED by the Board of Education of the Garfield Heights City School District, County of Cuyahoga, State of Ohio, that:

Section 1. This Board finds, determines and declares that the amount of taxes which may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of the School District, and that it is necessary to levy a tax in excess of such limitation for the purpose of general permanent improvements in the amount of 1.30 mills for a continuing period of time, and that the question of such additional tax levy shall be submitted to the electors of the School District on March 15, 2016.

Section 2. Pursuant to Section 5705.21 of the Revised Code, there shall be submitted to the electors of the School District at an election to be held on March 15, 2016, the question of levying an additional tax, in excess of the ten-mill limitation at the rate of 1.30 mills for each one dollar of valuation, which amounts to 13.0 cents for each one hundred dollars of valuation, for a continuing period of time (commencing with a levy on the tax list and duplicate for the year 2016 to be first distributed to the Board in calendar year 2017) for the purpose of general permanent improvements.

Section 3. A copy of this Resolution shall be immediately certified to the County Fiscal Officer of the County of Cuyahoga for the calculation by the County Fiscal Officer of the total current tax valuation of the District and the dollar amount of revenue that would be generated by the 1.30 mill levy.

Section 4. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with the law.

Section 5. This Resolution shall be in full force and effect from and immediately upon its adoption.
