RECOGNITIONS/COMMENDATIONS

SUPERINTENDENT'S REPORT

Promises Made to the Community. Promises Kept.

Just before the community of Garfield Heights passed its first voter approved request for new operating funds in March 2012, the district had more or less scaled back educational and extracurricular programming, services and opportunities for our students to the bare minimum. When the levy did eventually pass, district officials aggressively proceeded with a game plan to restore some of the most important items that had been cut. We are proud to announce to the schools and to the community-at-large, that many of these programs, services and opportunities are now being fully restored, and I'd like to share some of those with you, right now.

First and foremost, school day hours have been restored to normal standards, and bussing is back to systematic schedules for our students' safe and consistent transport to and from school. In addition, prized supplemental educational programs such as Elementary PE, Music, Art and Library are all underway this school year for our students. Hot lunches, once provided and then cut leading up to the levy, are now being provided once again. After hours usage of buildings and facilities is now promoted, where at one point, those opportunities had been eliminated. And, field trips are now a valued component, once more, in our students' educational experience. The restoration of tutors throughout the entire district has been another welcomed component for our students' education, because with this, we can provide them with the small group, and one-on-one attention that is so vital to education today.

The district made promises to the community for restoration of such components to our student educations, and it can now rest assured that the restorations are fast underway. Extracurricular activities, which are important to the full student experience, have been reestablished with little or no fees associated with participation. And school fees for K-8 have been eliminated altogether. Making good on these promises to the community was priority number one, when I became superintendent. Doing so has essentially permitted us to even enhance opportunities for academic achievement in a safe learning environment. For example, we recently hired a part-time security guard at Garfield Heights Middle School, and this is in addition to the one full-time and one part-time security guard already at the High School. This is done so that we can ensure safety for our entire student body. An additional safety and security component, which I reported on briefly last month, and wish to reinforce once again, is the use of outside funds to improve our overall technology infrastructure, including an advanced phone system AND improved and increased number of security cameras... essential to ensure this safe environment.

Clearly, there are a lot of positive things going on at the Garfield Heights City Schools. When the community entrusted us with additional resources, I made a pledge as superintendent that each and every dollar would be properly allocated, for the students' best interest.

The Garfield Heights City Schools plans to continue transforming lives and preparing our students with 21st Century Skills. With these reinstated educational programs, services and opportunities, and all of those to come in the future, we will be doing just that!

Dear Parents, Guardians and Members of the Garfield Heights City Schools Community,

The tragic events of this past Friday at Sandy Hook Elementary School in Newtown, Connecticut, have undoubtedly and unfortunately impacted the lives of so many people across this country, and I am certain that this tragedy has affected the families in our community as well. Our collective thoughts, prayers and sympathies are extended to the families of the Sandy Hook elementary community, as they grieve the events which have unfolded. The Garfield Heights City Schools want you to know that the safety and security of our children and staff is our top priority.

The following protocols, procedures and precautions that are in place, include:

- The district has a comprehensive safety plan in place that is regularly reviewed by staff and by our local public safety officials, local hospitals, and even statewide organizations.
- Each building in the district has its own, dedicated "safety team" that regularly performs exercises to keep individuals prepared in case of an emergency.
- An Increased number of security cameras have been installed in all buildings.
- Additional security personnel have been hired at the Middle School and the High School.
- All doors are locked after the students arrive and visitors must be "buzzed" into the building.
- Staff members are trained that all visitors must have a visitors badge. In fact, all adults must have an employee badge or a visitors badge to acknowledge that they are allowed to be in the building.
- The schools regularly communicate and coordinate with the public safety forces in Garfield Heights.

This tragedy strikes at the very heart of all of those who have loved ones and who entrust the safety and security of them in the hands of other people. Despite this seemingly senseless attack, there are tremendous acts of heroism that are emerging from new reports about teachers and administrators who sacrificed their lives to make sure more people were not hurt or injured. At this time, we at the Garfield Heights City Schools will grieve with those in and around the Newtown, Connecticut area and specifically the Sandy Hook Elementary Community. Our continued sympathies remain with those families.

Please know that if you have any questions, comments or concerns, my door AND my principals' door, is always open to you and the entire community.
