

<u>Title I Parent and Family Engagement Policy</u> 2019-2020

Goal Statement and Commitment

At Maple Leaf Elementary School, we believe that ALL STUDENTS WILL ACHIEVE AT HIGH LEVELS. It is our goal that every child should have the opportunity to attain his/her full potential.

The Instructional Focus will include the following:

Therefore, Maple Leaf Elementary School will maximize its resources to enable each child to become a successful learner. Key resources include administrators, teachers, school staff, parents and community members. We will work together to establish effective partnerships. School and home must work together to realize high student achievement. Ongoing, two-way meaningful communication will occur to facilitate mutual understanding and to stimulate student success.

Maple Leaf Elementary School will make every effort to include parents in the development, evaluation and revision of the Title I Program and the Parent and Family Engagement Policy. Jointly Developed
