#### BOARD PRESIDENT'S REPORT

Mr. Dobies wished everyone a good evening and welcomed all in attendance.

I would like to remind those in attendance that if you wish to speak in front of the Board, you must sign in. You have the opportunity to speak on agenda items prior to the Board taking action on the matters at hand. You also have the opportunity to make remarks on non-agenda items at the end of business matters. In both cases, you will be allotted three minutes to make your presentation. Thank you.

During this evening's meeting, we will hear updates from Mr. Jeff Henderson of TDA (ThenDesign) and Mr. Pete Devine from PCS.

At the June Board meeting, I reported the Board met in Executive Session on Tuesday, June 15, 2010, to discuss the proposed objectives going forward with the Budget Recovery Plan coming into the 2010-2011 school year. The plan included a reduction \$2.1 million to the budget. This included staff reductions, immediate and ongoing reorganization of staff, wage freezes, overall budget cuts for supplies and services and an equitable way of continuing extra-curricular activities, which has been implemented.

I also reminded everyone the task of finding new monies to supplement the districts needs remains high priority and the Board would move forward as to recognizing those needs and doing what is necessary to ensure a fiscally sound district while providing the highest education opportunities of which we can remain proud.

On August 3, 2010, a special meeting was held for the purpose of approving the second resolution to place an additional levy on the November ballot. This passed unanimously. The district will place an 8.9 mill levy on the ballet which will generate approximately \$3.9 million per year over five years. The decision was made based on the district's forecast and needs.

You may ask how the district can continue to ask for addition funding when times are tough.

First, I remind everyone it is the "Fiscal Duty" of all Board Members and administrators that we ensure the highest quality educational means for our children that we can provide with the resources provided by you, the taxpayers, on a balanced budget which is mandated by the state. We have to have a balanced budget annually. Although Mr. Sluka's preparation of the forecast is made on skilled and experienced assumptions as to where we will be in the future, we do have fixed costs but many are not so, the crystal ball may have error. The inflation of goods, services, legal requirements and continual or expanded services expected by parents and our community impact how we can approach the needs of the district. This is a complex area in that we are continually trying to be as progressive as possible to ensure our strategic plans for the district remain intact.

Second, as Mr. Sluka has informed the public on many occasions on the state of funding in Ohio, I will refer to what our county Treasurer, Mr. Rokakis, states, "Most revenues available to schools are fixed and inflexible, the cost of education continually rises. Many of the rising costs are out of the control of local school districts."

Much has to do with mandates served by state and federal law which there are little and or no monies given to provide these directives but has to be absorbed by the district.

Just a few examples of the laws which requires public schools to do:

- Ohio law requires bus transportation for all children K-8 who reside over two miles from school and must prove the same level of transportation service to non-public students.
- Special education services "MUST" be provided for all children in the district who qualify under state and federal guidelines regardless of costs. (This faction of education in our district continues to grow projecting 10% increases over years 2011 to 2014.)
- By law we must employ one teacher for every twenty-four students K-4. We are impacted by Ohio law from staff reductions because of economic hardship. Approximately 80% of the budget is used for personnel. Ohio collective bargaining laws "REQUIRES" Board to negotiate salary and benefit levels with employees.
- HB 920 from the seventies doesn't allow levies to adjust with inflation prescribing the need for continually asking for additional monies. And the list goes on.

As a Board we take those requirements seriously and adapt to what needs to be done required by law and needs of our student body within the scope of our budget. One does have to understand when those things exceed the proposed budget and we are still compelled by law to do them, something has to give. As we move into the future, the five year forecast presents a picture of larger deficits which we will have to deal with if no new monies come forward. I can assure you that this Board will move forward as best it can within the resources provided.

Since 1992 there have been no new monies apportioned to the district. We have all heard this over the years, but I believe sometimes some people fail to understand that this Board and administration (and this is not a pat on the back) have diligently used funding that they have been entrusted with, with minimal suffering during that time. I have to say if there was truly wasteful spending over the last eighteen years this district would have been in fiscal emergency a long time ago.

If we are to go forward, it is imperative that we move in a direction of helping ourselves, because at this time, no one else is going to do it.

What we need as a district is a continued understanding and support of everyone through demanding times. WE can only move forward as a "TEAM EFFORT". Thank you.
