To be designated as a Master Teacher in Ohio, eligible educators must clearly demonstrate criteria from the Ohio Standards for the Teaching Profession such as consistent leadership, focused collaboration, distinguished teaching focused on students and environment, distinguished teaching focused on content, instruction, assessment, and continued professional growth.
