A review took place of ORC Ann. 3313.665 (2010) as to the conditions for adoption of a dress code or school uniform. As requirement for the adoption of a dress code or school uniforms parents of students in the district must be given six months notice.

A timeline and action steps needed to be taken was then discussed by the Board. A review of Bedford City Schools and Fremont City Schools timeline took place.

Discussion then centered on the opportunities the Board would want to give principals, staff, and parents for suggestions and comments. It was determined that utilizing the various resources available to the district that surveys could be distributed to parents for input. The Board reviewed Bedford City Schools' survey sent to parents. It was determined that the surveys should be started for December/January completion.

In addition, as part of adoption of dress code or school uniform, the Board addressed procedures to assist parents of economically disadvantaged students. Possible sponsors and partnerships were discussed. The Board reviewed exceptions to policy related to days when recognized youth organizations have a scheduled function.

Lastly, a working timeline was discussed and established.
