

# <u>Title I Parent and Family Engagement Policy</u> 2019-2020

## **Goal Statement and Commitment**

We will work together to establish effective partnerships, and work together to promote student achievement. Ongoing, two-way, and meaningful communication will stimulate student success.

The faculty of our school is committed to the success of each student and recognizes the vital role of parents. We believe a partnership must exist and strive to promote communication and participation of parents in the education of our students.

William Foster Elementary School will make every effort to include parents in the development, evaluation and revision of the Title I Program and the Parent and Family Engagement Policy.
