

How are we implementing PBIS at our school in Tier 1? Tiered Fidelity Inventory (TFI)


Our most recent Tiered Fidelity Inventory (our PBIS assessment) indicates that we are implementing Tier 1 with fidelity at 97%. In our action plan, we have focused on features that scored a 0 or 1 to improve our implementation.




Self-Assessment Survey (SAS)


The Self-Assessment Survey (SAS Survey delivered in February 2022) indicates that as a school-wide approach, we are implementing Tier 1 with fidelity at 72% in place, 21% partially in place, and 8% not in place. In non-classroom settings, we are implementing Tier 1 with fidelity at 68% in place, 26% partially in place, and 6% not in place. In classrooms, we are implementing Tier 1 with fidelity at 60% in place, 27% partially in place, and 13% not in place. At the individual level, teachers report that they are implementing Tier 1 with fidelity at 59% in place, 22% partially in place, and 19% not in place.

Self-Assessment Survey Total Score






Non-Classroom Improvement Priority William Foster Elementary School 2/18/2022







What is our Office Discipline Referral (ODR) rate?

We have had 510 office referrals as of 4/4/2022 (when this report was generated). Office referrals are for major and minor infractions of the student code of conduct that may or may not result in school consequences. According to the triangle data report, 82% of students received 0 or 1 office referrals, 12% received 2-5 office referrals, and 4.6% received 6+ office referrals.

Provided Tier 2 interventions for the 2021-2022 school year include: CICO, Chart Moves, Break Passes, Sticker Charts, Zones of Regulation, 1:1 Outside Counseling, and Group Counseling. Number of students receiving Tier 2 interventions listed in the chart below.

Our most recent Tiered Fidelity Inventory (our PBIS assessment) indicates that we are implementing Tier 3 with fidelity at 91%. In our action plan, we have focused on features that scored a 0 or 1 to improve our implementation.

How effective are our Tier 3 interventions?

All students receiving Tier 3 supports have their own individualized Tier 3 Student Support Plan. If further intervention is required, a Functional Behavior Assessment (FBA) is conducted to determine the students needs in order to create a Behavior Intervention Plan (BIP). The team meets monthly to review the students progress toward their goals.
